

BID PROCEDURE

- All bidders must fill in **<u>BID FORM</u> <u>BID FORM ANNEX</u>** completely. Including:
 - A. Dimensions of playing area/areas
 - B. Names of the hotels, dimensions of the types of hotel rooms, and the number of rooms in each hotel
 - C. Rates of single, double, triple and family rooms in each hotel
 - D. Number of boards for live transmission
 - E. Parallel activities seminars, blitz tournaments, excursions, physical and cultural activates.
 - F. Parallel activities for Cadets, Youth and Junior Individual and Teams Events:

It is recommended to organize special blitz tournaments for official coaches and heads of delegations (if they have FIDE ELO) with a prize fund at least 2 000 \$ within the youth events - the FIDE World Cadets, Youth, Junior individual and Teams Championships.

It is highly recommended to organize corresponding World Chess Solving Championships during the FIDE World Cadets, Youth, Junior individual and Teams Championships.

It is recommended to organize some physical and cultural activities during the FIDE World Cadets, Youth, Junior individual and Teams Championships.

All above mentioned will be taken into account while evaluating respective bids.

- G. Confirmation of buffet breakfast, lunch and dinner in all official hotels
- H. Confirmation of the next menu (it can be improved by the organizer)
- I. Confirmation of transportation between the official hotels and playing hall (both way)
- A bid for any FIDE Competitions onwards shall include the name of a FIDE licensed International Organiser.

- BID FEE Any bidder must pay a bid fee until the bidding deadline. Bid fee is not refundable. If the bid fee is not paid, the bid will not be considered valid.

- DEPOSIT FEE Within a month after being awarded FIDE Chess Championships, the organising member federation shall pay deposit fee according to General regulations of FIDE competitions. When the event has been successfully concluded (according to the bid and the regulations), the deposit fee shall be credited to the account of the organising federation or refunded.

- The bidding federations are responsible for providing high resolution photo & video (using wetransfer.com) descriptions of:
 - A. The playing area with its full lighting
 - B. Other areas in the playing venue, including toilet facilities
 - C. Hotel rooms standard, deluxe and suites

If the above-mentioned information is not provided, the bid will not be considered.

- EVE will make inspections. The first inspection will be within four months after the bid deadline. If the organizer is granted with the event, EVE will define the number and necessity of pre-tournament inspections. Single FB accommodation in one of the official hotel and domestic transfer costs of the inspections must be paid by the organisers.
