

16. FIDE World Cup under 8, 10, 12

GENERAL REGULATIONS & RULES

1. The FIDE World Cup Under-8, Under-10 and Under-12 (hereinafter referred to as the “W-Cup”) shall be governed by the FIDE General Regulations for Competitions and these Regulations.
2. W-Cup is organized under the aegis of the Events Commission (hereinafter referred to as “EVE”).
3. The competition should be held annually between 15 of June and 1 of August.
4. At any time, any circumstance or unforeseen situation not covered in this regulation shall be referred to EVE commission upon authorization by the FIDE President for any kind of amendments and special arrangements.
5. Priority table for the event:

Year	Continent
2028	Europe
2029	Asia, Africa, America

6. If the bids received for the 2028 edition from European federations do not meet the standards established by FIDE EVE, the competition may instead be awarded to a federation from Asia, Africa, or the Americas.
7. If the bids received for the 2029 edition from Asian, African, or American federations do not meet the standards established by FIDE EVE, the competition may instead be awarded to a European federation.
8. FIDE EVE reserves the right to modify the continental priority principle whenever deemed necessary.

PARTICIPATION

9. The FIDE World Cup shall be held in six (6) categories: Open Under-8, Open Under-10, Open Under-12, Girls Under-8, Girls Under-10, and Girls Under-12.

10. Players who have not reached the age of 8, 10, or 12, respectively, before 1 January of the year in which the World Cup is held shall be eligible to participate in the corresponding age category.

11. Subject to compliance with Rule 10, the following players shall have a personal right to participate:

a. The top three (3) finishers in the corresponding age category of the previous edition of the FIDE World Cadets Championships.

These players may compete either in the same age category, provided they remain age-eligible, or in the next higher age category. For example, the winner of the Under-10 category may compete either in the Under-10 category (if still age-eligible) or in the Under-12 category.

b. The Continental Cadets Champions from the year preceding the World Cup.

12. Each FIDE member federation may register one (1) invited player in each of the six (6) categories (Open Under-8, Open Under-10, Open Under-12, Girls Under-8, Girls Under-10, and Girls Under-12), for a maximum of six (6) invited players per federation.

13. In addition to the invited players referred to in Rule 12, each FIDE member federation may register an unlimited number of additional players.

SCHEDULE AND SYSTEM

14. W-Cup will be a 11-round Swiss system tournament.

15. The time control is 45 minutes for each player plus 30 seconds per move starting from move one. The default time is 15 minutes.

16. The tournament schedule shall be as follows:

17. The ranking is determined by the number of points. The tie-breaks are:

- Direct Encounter (only if all tied have played each other)
- Buchholz Cut 1
- Buchholz
- The greater number of games played by black
- The greater number of wins
- Drawing of lots

FINANCIAL REGULATIONS

18. The Organizing Committee shall provide free board and lodging (in twin share rooms) for players mentioned in Rules 11 & 12 above from arrival day (lunch) to departure day (breakfast), as well as for one accompanying person per federation provided he holds a FIDE ID.
